ELIGIBILITY

All Scottsdale Artists' School non-faculty alumni, who have taken a class or workshop since January 1, 2011, are encouraged to enter.

All artwork(s) must be original subject matter, executed independently, outside of a class or workshop within the past three years.

JURORS

Jurors and judges for The Best and The Brightest will be chosen from the School's artist instructors, as well as local gallery owners, magazine editors and professional artists.

AWARDS

Best of Show Award

The Best of Show will receive a \$500 cash prize and a \$500 gift card presented by Arizona Art Supply and a \$750 gift card from Scottsdale Artists' School

First Place Award (Each Category)

Each award winner will receive a \$500 Scottsdale Artists' School gift card.

Second Place Award (Each Category)

Each winner will received a \$200 Scottsdale Artists' School gift card.

Fine Art Connoisseur Award of Excellence

One full page award advertisement in Fine Art Connoisseur Magazine

PleinAir Magazine Award of Excellence

One full page award advertisement in PleinAir Magazine

People's Choice Award

The award is chosen by popular vote of the attendees at the opening reception. Winner will receive a \$100 Scottsdale Artists' School gift card.

Scottsdale Artists' School Purchase Award

COMMISSIONS

Scottsdale Artists' School will retain a 50% commission on all paintings and drawings (30% on sculptures) sold during the show. The remaining funds will be paid to the artist following the close of the show. Purchasers' names and addresses will be provided to the artist.

RISK AND LIABILITY

All entries are made at the risk of the entrant. Care and caution will be made in the handling of all artwork(s). Neither Scottsdale Artists' School nor its agents may be held liable for any loss or damage to any entry while it is in possession of Scottsdale Artists' School or its agents. Insurance during the exhibition is the responsibility of the artists. Entry in the show and signature on entry form constitutes an agreement with all conditions in this prospectus, including the right to photograph artwork(s) for publicity or archival purposes.

The decision of the jurors is final. The jurors will determine how many artworks are suitable for display and sale. All artwork(s) in the exhibit will be offered for sale. There is no guarantee that any artwork will be sold. By entering this juried competition, you give the Scottsdale Artists' School permission to publicize, advertise and/or promote your artwork(s).

CONDITIONS

- All artwork(s) must be available and priced for sale.
- Artists may submit three artworks from the medium of Oil Painting, Water Media, Drawing/Pastels, Sculpture or Miniature. One or all artworks may be selected at the discretion of the jurors.
- Artwork(s) must be securely framed and ready to hang. All 2-D artwork(s) must be framed with two screw eyes or two D-ring hangers with wire in place.
- The \$40 entry fee is not refundable.
- Substitutions of artwork(s) or price changes will not be permitted after the entry form is received.

SIZE LIMITS

- 2-D artwork(s), maximum dimensions are 18" x 24", unframed.
- Sculpture, maximum weight is 50 lbs. and maximum dimensions should be no larger than 18" high or wide.
- Maximum dimensions for miniature 2-D artwork is 18" x 24" or smaller; sculpture should be no larger than 8" high or wide.

SUBMITTAL REQUIREMENTS

- Submit images via email or CD
- Completed Entry Form
- \$40 non-refundable entry fee

SUBMITTING DIGITAL IMAGES VIA EMAIL

Images may be submitted as attachments via email to wstillions@scottsdaleartschool.org. Please identify all images by name of digital file, title of artwork, medium, size, and price in the body of the email. Images must be high resolution (300 dpi) .jpg or .tif files.

Include your name, address, phone number in the body of the email.

Entry fees for electronic submissions may be paid two ways: Mail a check for \$40 to the School with your entry form, or call 480-990-1422 with your credit card information.

SUBMITTING DIGITAL IMAGES ON CD

For paintings and drawings, submit one view. For sculpture, two views of each piece may be submitted.

Images must be high resolution (300 dpi) .jpg or .tif files. Do not submit slideshows, PowerPoint presentations or images embedded in program files. Images must be of the artwork(s) being submitted for consideration. Artwork(s) that are different from the images submitted with the Entry Form will be disqualified. Please note: CDs will not be returned.

SHIPPING INSTRUCTIONS

Email notification of selection of submitted artwork(s) will be sent on or near November 11, 2014. If the jurors selected your artwork, you should plan to have it delivered to the School no later than December 19, 2014. Specific shipping instructions will be included with all acceptance notifications. Scottsdale Artists' School is not responsible for shipping artwork(s) to/from the School. **(The School is not responsible for artwork(s) lost or damaged during shipping. Insurance and proper packaging is highly suggested to protect your artwork.)**
